Recent report by the Royal College of Physicians - Every breath we take: the lifelong impact of air pollution

The report states that in the UK 40,000 early deaths every year are attributable to outdoor air pollution, mainly from nitrogen oxides (NOX), including nitrogen dioxide (NO2) and particulates. Over 9,000 of those deaths are in London. Air pollution has been linked to cancer, asthma, stroke and heart disease, diabetes, obesity, and dementia. Health problems resulting from air pollution cost the UK more than £20 billion every year.

Legal Challenge

The legal challenge by an anonymous resident was funded through a combination of legal aid, pro bono work and crowd funding from supporters which raised £16,000. Dr Paul Stookes, Richard Buxton Environmental and Public Law Solicitors is acting on behalf of the local resident. A judicial review was granted which came to court in July. Mr Justice Collins stated that no errors had been made by the council in making the decision. An appeal is pending. Dear.....

I am writing to express my deep concern with regards to the planned Enderby Wharf Cruise Ship Terminal in the Royal Borough of Greenwich (RBG); its lack of provision of onshore power for berthed vessels, its impact on air pollution and subsequently its impact on public health.

Air pollution was called a "public health emergency" by MPs in April of this year. Over 9,000 people in London die early every year due to air pollution. The resulting health problems cost the UK more than £20 billion. Nitrogen dioxide (NO2) and particulate matter (the main components of air pollution in London) are produced from burning diesel fuel. The ships berthed at the Cruise Ship Terminal in Greenwich will use diesel fuel.

TRBG's own Air Quality Report (published in 2014) states that air quality is sufficiently poor for Greenwich to be designated an Air Quality Management Area and that "the annual mean objective for NO2 is expected to be exceeded (irrespective of the proposed development at Enderby Wharf)". It is clear that Greenwich and specifically the areas surrounding the planned terminal are already a pollution hotspot, with this year's air quality measurements carried out by RBG and the East Greenwich Residents Association (EGRA) showing alarming levels of NO2.In places it is over twice the statutory limit. Government guidelines clearly state that if a project leads to non-compliance with a statutory limit, decision makers should refuse consent. This should surely extend to developments that will make air quality worse in an area where it is already breaching those limits.

As it stands, RBG will allow cruise ships at the planned terminal to use their polluting on-board engines burning 700 litres of diesel an hour; the equivalent of 688 heavy goods lorries idling around the clock, even though clean on-shore electric power is possible and supply readily available. This is a disastrous decision in a densely populated residential area with several schools nearby. The RBG are doing this in the face of overwhelming local opposition, exemplified by a crowd funded legal challenge by one resident. The developers (Barratt Homes) say that it would be prohibitively expensive to install on-shore electric power, despite substantial profits due to be made from selling nearly 800 luxury homes on the terminal site.

I ask for your support in pressing RBG to reconsider the planning decision and mandate on-shore power both for my health and others living in this area. [change this paragraph if sending to RBG, Morgan Stanley, Barratt or London city cruise port]
