

Trafalgar Road (West) Improvement Scheme

Consultation Document

September 2017



Why are we proposing this scheme?

Trafalgar Road is a busy corridor served by six bus routes and is a key traffic link between Greenwich town centre to the west and the A102 Blackwall Tunnel Southern Approach to the east. Concerns have been raised over peak time delays on Trafalgar Road and so the Royal Borough of Greenwich are looking at options to improve traffic flow.

The signalised junctions of Trafalgar Road with Greenwich Park Street and Maze Hill are less than 90m apart and traffic surveys show that westbound traffic queuing at the Greenwich Park Street junction often impacts the efficient operation of the Maze Hill junction.

This results in traffic on Trafalgar Road and Maze Hill not being able to enter the junction even when the signal is green which is causing delays particularly during the morning rush hour.

A lack of green man facilities across Maze Hill are also making it difficult for pedestrians to cross this road.

What is being proposed?

We are proposing to remove the traffic signals at the junction of Trafalgar Road and Greenwich Park Street. The junction will revert to priority control with traffic on Greenwich Park Street giving way to traffic on Trafalgar Road.

To ensure that vehicles wishing to turn right into Greenwich Park Street from Trafalgar Road do not obstruct other traffic a new right turn lane will be included. This also provides an opportunity to create a pedestrian refuge island on the western side of the junction which will allow informal crossing opportunities in place of the signalised crossing. The existing signalised crossing facilities at Maze Hill and further west at Park Row will be retained.

A new raised entry treatment at the junction of Greenwich Park Street and Trafalgar Road will also provide pedestrians with step free crossing across Greenwich Park Street.

The removal of the signals also allows us to increase the amount of green time for traffic on Maze Hill as well as introducing a new green man facility across Maze Hill. These changes will see journey time savings for all traffic but especially Maze Hill where significant reductions in journey times and queues are expected. Reduced journey times on Maze Hill will also likely result in fewer vehicles undertaking an illegal left turn into Park Vista from Maze Hill.

Once the consultation period has finished a decision will be made as to whether the scheme will go ahead or not.
